The resolutions contain all of the information and references needed for you to write a compelling essay. Write a 2-3 page essay (no more than 750 words) on the following prompt:

An analysis of the issue including your rationales for why the topic is important. Include a description of what the issue is, why it is relevant, and why it should be addressed by the legislative process. Is there anything you would change about the resolution? Is there any current legislation supporting this topic or has it been addressed by the State of California? Please be clear and concise in expressing and supporting your arguments.

**Part 4:** Please write a brief sample email (about two paragraphs) that you would send to your state legislator. In your email, express a healthcare issue that you'd like to see the government address, a brief summary of how you believe the issue should be addressed, and request they consider the proposal for adoption.
