Why write a resolution?





- A resolution is a written statement that, when adopted by the House of Delegates at the Annual Conventions of NSNA and/or CNSA, becomes the basis for the policies and actions of the National Student Nurses' Association (NSNA) and/or the **California Nursing Students'** Association (CNSA).
- This means that <u>YOU</u> can make a difference in the nursing profession!
- Your work can bring awareness, recognition, and/or advocacy to your topic!

What is the difference between submitting to CNSA and NSNA?

Short answer: Same resolution, two submissions.

In chronological order:

Now- September 5th, 2025 (First Draft Due to CNSA)

Write your resolution!

September 2025- October 2025

 Work with CNSA Resolutions Committee in preparation for CNSA Convention.

November 14th, 2025 (Start of CNSA Convention)

 Your resolution along with all other submitted/approved resolutions will be presented to the CNSA House of Delegates (HOD). You will defend your resolution and the HOD will vote on which ONE will be nominated.

November 16th, 2025 - January 15th, 2026 (Submission Due to NSNA)

- IF NOMINATED: In addition to becoming the basis of actions and policies of CNSA, you will have the support of CNSA in submitting, sponsoring and finalizing your resolution.
- IF NOT NOMINATED: You still can and <u>SHOULD</u> submit your resolution! The Resolutions Committee can still offer advice and critique, however, it will not have the sponsorship of and submission with CNSA.

April 2026 (NSNA Convention)

The Resolution

- Resolutions are your opportunity to spread awareness for, advocate for, and promote certain aspects of nursing education and/or the nursing profession that you believe needs more attention!
- Resolutions address only <u>one topic</u> or issue, be national in scope, and fall within the purposes and functions stated in the NSNA/CNSA Bylaws and Mission.

The Resolution cont.

The Resolution consists of:

- 1. Topic (Title) (MAX 15 words)
- 2. Submitted by: (Your school)
- 3. Authors: (You and your co-authors)
- 4. "Whereas" Statements (MAX 300 Words)
 - Factual statements that express the need for a resolution.
 - b. Each statement is cited APA 7th ed.
- 5. "Resolved" Statements (3-5 Statements)
 - Express the actions you would like NSNA and/or CNSA to take.
 - b. Influence policy and focuses of the organization

- If your submission is accepted by CNSA for the CNSA Annual Convention (November 14th, 2025), it will require less work to fulfill the qualifications of NSNA for the NSNA Annual Convention (April 2026).

The Final Product

The final product that will be submitted to both organizations consist of 6 documents:

- 1. Abstract (Topic, Submitted by, Authors, Abstract)
- 2. Estimated Cost: Itemized the estimated cost to NSNA to implement the resolution.
- 3. Contacts: (An excel file of the organizations you would like a copy of your resolution to be sent to, if nominated)
- 4. The Resolution
- 5. List of References (This list and in-text citations are APA 7th Edition)
- 6. Reference Documents (All files for references listed in List of References and cited in "Whereas" statements.)

Who? Submitting and Authoring

Who may submit a resolution?

NSNA constituent state associations,
NSNA/CNSA constituent school chapters,
NSNA Board of Directors, and NSNA
Committees may each submit one resolution
for consideration by the House of Delegates.

Individual NSNA/CNSA members may not submit resolutions. Constituent school and state chapters are those that have met the current requirements for official NSNA Constituency status.

Who may author a resolution?

Only NSNA/CNSA student members may be the resolution authors. Faculty and faculty advisors are available only to guide student authors and are not to take an active role in deciding the topic or writing the resolution. There may be only one primary author and additional authors.

All authors must be current students and NSNA/CNSA members at the time of the Annual Convention.

Types of Resolutions:

1. <u>Resolutions of Substance</u> serve as one means by which opinions may be expressed, purposes of the NSNA/CNSA can be implemented, and directions are given for future action. **This is what you will be creating.**

- 1. <u>Courtesy Resolutions</u> recognize contributions made to the organization (CNSA and NSNA) by groups and/or individuals; i.e., honorary by acclamation
- 2. <u>Emergency Resolutions</u> are resolutions on a topic that arises subsequent to the resolutions deadline date.
- 3. Reaffirmation Resolutions restate a position previously taken by the NSNA. (Within the previous 5 years) This type of resolution is accepted only under special circumstances so we want to avoid this. NSNA explains in their guidelines that Resolutions of Substance topics must have not been presented within the last 5 years.

TOPIC:

1. Choosing the Topic, Position, and Actions to be Taken

The <u>first step</u> is to determine a national issue that is relevant to the NSNA and/or CNSA, nursing students, the nursing profession, and healthcare policy.

Topics must be national in scope, be able to be implemented within NSNA's resources, and should fall within the mission, purposes, and functions as stated in the NSNA Bylaws and mission.

This is your time to shine! Research topics that <u>YOU</u> are passionate about!

Things to Consider:

- Topics should not have been nominated within the last five years.
- CNSA's Resolutions Archive
- NSNA's Resolutions Archive

2. Documenting the Need

.........

WHEREAS.

Because each "Whereas" statement reflects the need for the resolution, each "Whereas" statement must cite a supporting reference/document. All supporting documents must be submitted with the resolution.

While "Whereas" statements must accurately reflect the supporting documentation provided, <u>direct quotes</u> <u>should be avoided</u>.

The documentation must be evidence-based and no more than 5 years old (2020), unless the information is historical in nature.

| WHEREAS, | Nurses are the largest group of health professionals in the country, and if policy makers and other key decision makers know that nurses are in agreement on important issues, they listen and often take action (Institute of Medicine, 2011, p.240); and |

- For references and citations, authors <u>must</u> use the Publication Manual of the American Psychological Association (APA), 7th Edition.

In my experience, formatting the resolution correctly is just as hard as composing it. Do not leave this until the last minute!

ABSTRACT: Nurses have a growing impact on how they influence patient care, healthcare

policies, and healthcare spending. Nursing unions provide a method for nurses to be aware and involved in voting and creating health policies that not only advance patient rights but also the nursing profession. educating themselves in health policy as future nursing professionals.

5. Reviewing, Proofing, and Organizational Approval of the Resolution

- Reach out to your chapter Executive Committee/Board, classmates, and faculty advisors for critique and advice!
- Ensure that your Resolution is the best version of itself!
- When submitting to NSNA, you do not need the approval of CNSA to do so!
- Plan for early submission to avoid last-second troubles.

DEADLINE FOR NSNA: January 15TH, 2026

6. Submitting the Resolution

- This is the moment we have all been waiting for..
- Click Me: NSNA's Resolutions Guidelines outlines all components you need and how to submit.
- Submission links/forms will appear on the CNSA/NSNA Resolutions Committees' websites in the months leading up to the deadline.
- The earlier you submit your work, the earlier it can be reviewed.

After Submission

First Draft To CNSA: (September 26, 2025)

- 1. Expect an email from the Resolutions Committee confirming your submission.
- 2. We will review your Resolution to ensure it meets the requirements outlined in NSNA's Resolution Guidelines 2025-2026.
- 3. Prior to CNSA Convention (November 2025), we will work with you to prepare you for presenting and defending your resolution at convention!
- 4. Please ensure your email address and phone number are updated to ensure timely communication.

To NSNA: (January 15, 2026)

- 1. Expect an email from the NSNA Resolutions Committee confirming your submission.
- 2. After the review process, you will receive another email either approving or requesting changes for your resolution.
- 3. Prior to NSNA Convention (April 2026), they will work with you to prepare you for presenting and defending your resolution at convention!
- 4. Please ensure your email address and phone number are updated to ensure timely communication.

At Convention:

CNSA (**November 14, 2025**)

- You (and co-authors) will have the opportunity before your Resolution's hearing to answer any questions delegates may have about your resolution.
- This is your opportunity to garner support!
- In the House of Delegates: your resolution will be presented, defended, and voted on to potentially become CNSA's Nominated Resolution 2025!
- More details about Convention will be disseminated as we get closer!
